INTRODUCTION

1. The Government Institute of Medical Sciences (GIMS) Greater Noida, Gautam Buddha Nagar (UP) is an autonomous medical teaching institute established by the State Government of Uttar Pradesh, established since 15th February, 2016. The institute has started MBBS course for 100 students since 01 Aug 2019 and Post graduate courses in clinical specialties since 2020 though National Board of Examinations, College of Nursing for 60 students in 2021 and Paramedical school for 60 students in 2021.

2. GIMS was established with an aim to improve the status of health of the rural and urban population of western Uttar Pradesh, by providing a state-of-the-art health facility as well as facilitating equitable access to quality health care through a revamped health care system, targeted outreach services as well as involvement of community and local bodies. The Mission of the institute is to provide comprehensive medical facilities to each and every life without discrimination along with developing GIMS as a centre of excellence in the field of health delivery system, medical education and research.

3. Since Mar 2020, GIMS was nominated as dedicated Covid hospital by the Govt of UP and more than 5000 patients were managed with minimal case fatality. The institute has been at the forefront in COVID-19 diagnostics and done over 16 Lakhs RTPCR so far. We have more than 120 research projects out of which 17 are extramural with ICMR, NIMR and WHO.
