INTRODUCTION

- 1. 1. Procurement of goods on supply order basis: - Supply of material is covered under this rate contract will be made on the basis of written supply order issued from time to time. - 1. The bidders should not have been blacklisted/debarred to participate in the bids for medical supplies from any Government Department/Public Sector Undertakings of India.
- 2. The applicant should have valid license to manufacture/export the specific vaccines to India as per specifications mentioned in the EOI from the Competent Authority and/or Food and Drug Administration, Government of India.
- 3. The Vaccines to be supplied must be as per the guidelines issued by Indian Council for Medical Research (ICMR).
- 2.Taxes- Payable extra, as applicable
- **3. Security Money / Performance Security (Refundable):-** Rs.25, 000/- (Rupees Twenty Five Thousand only) will be submitted in shape of TDR/FDR in favor of "Director, Government Institute of Medical Science, Greater Noida & it should be valid for a period of 3 (Three) years from the date of RC.
- **4. Rate:-** Any variation in the rates detected at any point of time, the sole responsibility would rest with you and shall invite necessary action as deemed proper. Differential amount of the goods, if found on the higher side will be recovered from your dues & security.

If any material is not supplied within scheduled period or delivered material found not up to the mark, the institute reserves the right to terminate this EOI without assigning any reason thereof.

5. Fall Clause:- Shall mean, if at any time during the execution of the contract, the contractor reduces the sale price or sales or offers to sale such goods, as are covered under the contract of the institute, to any person/ organization including the purchaser or any department of Central / state Govt. at a price lower than the price chargeable under the rate contract, he / she shall forthwith notify such reduction or sale or offer of sale to the purchaser and the price payable under the contract for the stores supplied after the date of coming into force of such reduction or sale or offer of sale shall stand correspondingly reduced. In no circumstances, the rate will exceed the lowest price & in the event of price going down, the rate will be amended.

In case any supplier or bidder or dealer uses the Letter Pad or seal of the principle firm or signs any paper or bidding documents or submits any subsequent clarification or justification or rate chart on behalf of principle firm, which amounts to fake documentation & forgery, such supplier or bidder or dealer may be blacklisted for a period of two years in the institute either on complaint as & when or the facts is revealed during the scrutiny of documents or verification or on confirmation.

6. Liability on issuing false certificates etc.:- means a person who issues or submits a false or wrong certificate or declaration prescribed under any provision shall be liable for action.

- **7. Delivery of goods:-** Supplied material should have ordinarily minimum shelf life of 75% from the date of manufacturing at the time of delivery. Batch number and expiry date should be mentioned on challans and bills.
- **8. Liquidated Damages:-** means a terms used in respect of contract for supplies. The time for and rate of delivery is considered as the "essence of contract". If a contractor / supplier fails to supply the material at the time for and rate of delivery, stipulated in the order then the purchaser, under the provision of standard conditions of the rate contract, shall have the right to recover "Liquidated Damages", in order words, it is a penalty payable by the seller for his failure to deliver the goods in time.
- **9. Late delivery clause (LD):** shall mean the date and time of the delivery as stipulated in the supply order shall order shall be deemed to be the essence of the contract and delivery must be completed no later than the dates as specified in the orders. A penalty of 1% of the value of order per week will be imposed on delayed supply subject to a maximum of 10% of value of the orders. Extension in delivery period will only be permissible under the force major conditions for which specific extension must be obtained from the institute before the date of delivery at IRF store.
- **10. Maintenance of cold chain:** Documentary proof of maintenance of cold chain during transport of reagents / kits is to be provided by the supplier. 12. Tax invoice must be submitted in three copies at time of delivery of goods starting our GST No. 09AADAM0695B2ZP for claiming input Tax Credit duly signed & discharged on revenue stamp along with the receipt challan.
- **11. Terms of Payment:-** Payment shall mean 100% payment to the supplier on 30th"working days from the date of supply of goods in good & satisfactory condition or receipt in IRF (store). The pre-receipted bills will be submitted in five copies in GIMS (store) with necessary information.
- **12. Replacement Clause:-** Shall mean the items supplied nearing expiry and if not consumed, will be intimated in advance to you and will have to be replaced at your cost & risk, slow moving items may be asked for replacement with other approved items.
- 13. Challan must bear the following information:- supply order will be released and you may execute the supplies directly or through your authorized distributor. Challan must bear the information about name of the item as it was mentioned in supply order, name of the item as it is mentioned in your product literature, size of the Item, supply order number, supply order date, date of manufacturing, date of expiry, batch number and quantity of each item.

- 2. Each shipment of the drug must be supplied with Certificate of Analysis by Government lab or any NABL accredited drug testing laboratory approved by Government of India.
- 3. Drug with difference in specification, difference in packaging material or as specified in this EOI shall not be accepted.
- 4. The residual shelf life of the vaccines supplied by the successful bidder(s) must be as prescribed by the DCGI, Government of India, from the date of its supply to the GIMS, Greater Noida.
- 5. The Injection Vials should not be flip-off caps.
- 6. The labeling of drugs/items should comply with guidelines set forth by Drugs & Cosmetic Act and Rules applicable in the Country, specifically adhering to:
 - a. The label should prominently display the International Non-Proprietary Name (INN)/Proper Name or generic name as per labeling provisions of Drugs and Cosmetic rules.
 - b. Name of the Drug shall be mentioned in ENGLISH in primary and secondary packaging.
 - c. The secondary packaging materials (box, carton) must be clearly labeled with the names of the items, batch number, manufacturing date, expiry date and the number of units per carton/box.
 - d. The label in case of injectables shall clearly indicate that the preparation is meant for IM, IV, ID, SC, etc.
 - e. Consignment shall be liable for rejection if any tampering with expiry date is found.
