 g. For setting research priorities, the Institute shall form Local Research Advisory Committee; that Committee would identify the research projects. The quality of research work would be monitored by the ICMR/DHR.
 b. The Institute would immediately set up internal mechanism for project.
- The Institute would immediately set up internal mechanism for project implementation including recruitment of staff.
- The Institute shall nominate one senior level official from within the faculty as Nodal Officer of the MRU for interaction with the State Government and DHR/ICMR. The name of the Nodal Officer shall be intimated to DHR/ICMR immediately.
- The Institute shall ensure compliance with j. implementing the project.
