Vaccancy on Deputation

- 1- The maximum age limit for the appointment on deputation basis shall be 50 years for Junior Engineer as on the closing date of receipt of applications.
- 2- Supporting documents related to qualification, experience etc. has to be self-attested.
- 3- The pay and the other terms and conditions of the appointed candidate will be as per Govt. of U.P. as amended from time to time.
- 4- The application of the willing candidates may be forwarded in the proforma given at Annexure II, alongwith attested ACRs/APARs, vigilance clearance, integity certificate and a statement showing details of major / minor penalties imposed on them, if any, during the period of last 03 years, through proper channel. Bio-data of only those candidates, whose services can be spared within 1month on their selection, may be forwarded.
- 5- If the applicant feels that the application through proper channel will get delayed, the applicant should send an advance copy of his/her application within the prescribed time limit. The advance copy of the application shall be considered in the processing stage. However, in case the application along with the requisite documents is not received within 3 weeks after the last date for applications, it will be presumed that the parent organization is not in favour of appointment of the applicant on deputation.

The Maximum age limit for appointment by deputation shall be 'Not exceeding 50 years' as on the closing date of receipt of applications.
