## INTRODUCTION

1. 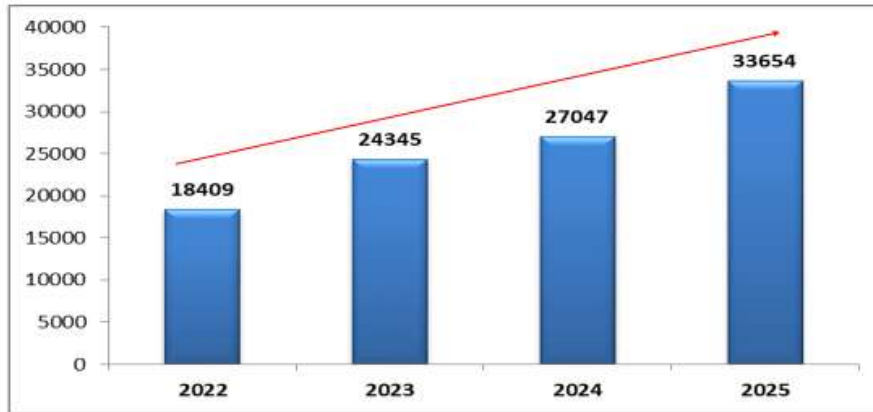

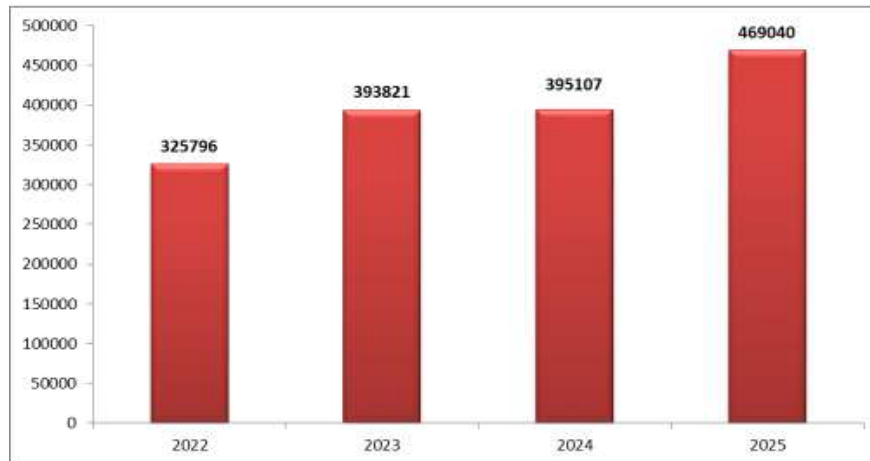


## IN-PATIENT WORKLOAD 2022-2025

## PROPOSAL

7. We are running OPD services of Cardiology bi-weekly for last four years and more than 5000 patients have been provided the consultancy so far. What began as a small outpatient care with 30-40 patients per month now accommodates 100-120 patients per month. GIMS is also running Oncology OPD on consultancy basis. Numbers of patients are also increasing day by day and apart from OPD services.
8. GIMS also have the Hospital Revolving Fund (HRF) and can provide medicines and consumables as per hospital guidelines.
