#### **FINANCIAL IMPLICATIONS-**

- 14. Interested agencies must submit an indicative financial proposal or rate sheet showing:
  - Price per kilogram/ton of scrap and paper waste (if applicable)
  - Price per unserviceable/unrepairable item per item (if applicable)
- 15. Interested party may visit the scrap items in the premises.
- 16. Proper accounting of item and gate pass to be obtained from the administration.
- 17. Payment to be made to the hospital before the item is taken out of hospital.
- 18. The financial terms may be reviewed annually, subject to market conditions, waste volume variations, or changes in government regulations
- 19. All financial transactions between the selected agency and GIMS must be properly documented, invoiced, and acknowledged.
- 20. GIMS reserves the right to audit financial records related to scrap collection and disposal as part of performance evaluation.

#### **GIMS RESERVES RIGHT**

- 21. To take final decision regarding empanelment or to modify or scrap the process,
- 22. To accept or reject the request of any agency for empanelment, and
- 23. To keep or remove any agency on the panel approved for outsourcing
- 24. To keep or remove any staff of the service provider involved in any unlawful activities.

#### **ELIGIBILITY CRITERIA**

#### Agency should have:-

- 25. The Applicant should have at least three years of experience in providing services to Government/Semi Government/Autonomous Body.
- 26. The Applicant should be registered with the authority concerned of the State or Central Government,
- 27. The applicant should submit the copy of income tax, PAN, GST certificate with valid registration Number.
- 28. The Applicant should have their office set up in Delhi NCR region.
- 29. The Applicant should not have been blacklisted by any Central/State Government/PSU.

#### **GENERAL TERMS AND CONDITIONS**

- 30. Applications should be submitted in the prescribed form only. Eligible and competent agencies will be short-listed for the EOI.
- 31. Agency will conduct regular collection of scrap and paper waste as per schedule agreed upon with GIMS.
- 32. Provide necessary manpower and equipment (vehicles, bins, safety gear, etc.) for the safe collection and transport of waste.
- 33. Ensure proper segregation, handling, and eco-friendly disposal or recycling of waste as per applicable environmental norms.
- 34. Maintain cleanliness and avoid spillage or littering during handling and transportation.

- 35. Maintain records of the quantity and type of waste collected and disposed.
- 36. Comply with all municipal, state, and national regulations regarding waste management. Empanelment of agency will be done on the basis of criteria enumerated in these documents along with professional competence.
- 37. The date of declaration of qualified/empanelled agency will be at the discretion of GIMS.
- 38. All the pages of the EOI are to be self attested.
- 39. The bidder has to furnish an undertaking that the organization has not been blacklisted in the past by any Government Departments /Boards/ Corporations or reputed Private Companies.
