#### SCOPE OF WORK

- 13. GIMS hospital is 630 bedded hospital. GIMS being the only Government Medical College in this region, caters for large no of patients of western UP, Haryana, Uttarakhand and Rajasthan. There are more than 1500 patients are visiting every day and more than 450 patients admitted in the hospital. The total no of patients reported in 2024 were 383467 OPDs and 27047 patients were admitted.
- 14. The agency will enquire patients planning to take treatment/ surgery or admitted at GIMS regarding empanelled insurance companies, cashless schemes, and eligibility criteria.
- 15. The agency will guide patients and their families regarding documentation requirements and preauthorization process and coordination with the hospital's admission desk to identify insured patients early in the admission process.
- 16. Agency will liaison with the treating department for preparation and liaison with TPAs for submission of pre-authorization requests and get approval.
- 17. Agency will maintain a dedicated helpdesk within the hospital premises, operational during all working hours.
- 18. Agency will prepare detailed claim documents and other supporting documents.
- 19. Agency will follow up with insurers for approval, partial settlement, or rejection clarification
- 20. Agency will ensure final settlement of claims in coordination with the hospital accounts department and agency will maintain patient records for audit and statutory compliance.
- 21. Agency will be responsible for addressing patient grievances related to insurance settlement.
- 22. Agency will provide daily, weekly, and monthly reports
- 23. Agency will ensure confidentiality of patient and hospital data as per applicable laws

#### Agency should have:-

- 30. Applications should be submitted in the prescribed form only. Eligible and competent agencies will be short-listed for the empanelment.
- 31. The Applicant should have at least three years of experience in providing TPA services to Government/Semi Government/Autonomous Body.
- 32. Must be empanelled with major public and private insurance companies
- 33. Must hold a valid IRDAI (Insurance Regulatory and Development Authority of India) license for functioning as a TPA.
- 34. The Applicant agency should be registered with the authority concerned of the State or Central Government.
- 35. The Applicant agency should submit the copy of income tax, PAN, GST certificate with valid registration Number.
- 36. The Applicant agency should have their office set up in the 50 KM radius from the GIMS Institute.

#### GENERAL TERMS AND CONDITIONS

- 37. Agency to be registered legal entity in India.
- 38. Proven track record in relevant projects (proof to be enclosed)
- 39. Empanelment of agency will be done on the basis of criteria enumerated in these documents along with professional competence.
- 40. The date of declaration of qualified/empanelled agency will be at the discretion of GIMS.
- 41. The TPA shall ensure complete confidentiality of patient data and comply with IT Act, 2000 and subsequent amendments.
